**Tanya Miller** (Atlanta) is comfortable in the spotlight, whether engaging the judge and jury in the courtroom, appearing as a legal analyst and commentator on broadcast media, or leading high-profile cases that have earned national attention for her strategies and successes.

He teamed up with his long-time partner, Ed Garland, in the defense of Ray Lewis, Jamal Lewis, Dany Heatley, and Rapper T.I. Don is ranked among the Top 100 Georgia Super Lawyers, has been listed in Best Lawyers since 1991, and was recognized in Georgia Trend magazine's Legal Elite for his work in criminal defense law. He is a past President of the GACDL, was elected in 1999 to membership in the American Board of Criminal Lawyers, and inducted into the American College of Trial Lawyers in 2000.

Don is the author of a treatise on Georgia criminal law, GEORGIA CRIMINAL LAW CASE FINDER and a treatise on criminal law in the Eleventh Circuit, ELEVENTH CIRCUIT CRIMINAL HANDBOOK.



**Lawrence Zimmerman** (Marietta) has been representing those accused of serious crimes for 20 years both in the state and federal courts. He has acquitted people of crimes ranging from murder to rape and reversed convictions in the appellate courts. He has been involved in many high-profile cases. In 2018, he received the prestigious *Gideon's Promise Award* from the Southern Center for Human Rights for his pro bono work for the man accused of setting the I-85 fire and was named to *Georgia Super Lawyers*. **Amanda Clark Palmer** (Atlanta) is a partner at Garland, Samuel, & Loeb, P.C. where her practice focuses on criminal defense in both state and federal courts. Most recently, she and her partner Don Samuel won a complete acquittal for their client – a doctor – who was charged with illegally prescribing opioids in federal court in Kentucky.

Before going to law school, Amanda worked for General Electric, first as a manufacturing engineer and then in sourcing. She has a B.S. in Industrial Engineering from the Georgia Institute of Technology and is a graduate of Georgia State University College of Law.
